- Parent or sponsor bank statement verifying the availability of funds, as long as the statement is in the parent or sponsor's name. Also include a signed letter from the parent or the sponsor indicating willingness to pay educational expenses.
- Documentation of scholarship(s) in the form of an official award letter from the government, school, or sponsoring agency.

Documents may be sent electronically (photocopies and facsimiles are acceptable).

Since some countries have limits on the amount of money that may be sent to the United States, it is important to inquire about the regulations of your country concerning the transfer of such funds.
